

LIMITED TENDER

Sealed limited tenders are invited for providing two vehicles (Gypsy) with drivers for **Driving Classes** for the Trainees of NEPA. at Barapani NEPA campus. The terms and conditions for providing vehicles are as under:

1. This tender can only be down loaded from our website www.nepa.gov.in and should be sent by post or dropped in the tender box kept at this office before 1400 hrs by 5th June 2009 which will be opened at 1600 hrs on that date by Board of officer in front of the bidders who wish to be present. No tender received after the due date and time shall be considered.
2. The firm will provide POL, other lubricants on their own expense at the time of driving classes along with driver who are holding valid driving license and has experience in conducting driving classes.
3. Driving training classes will start from 0900 hrs to 1200 hrs in the morning and from 1430 hrs to 1730 hrs in the afternoon.
4. During the driving classes, if any major / minor repair of the vehicles is required, the same will be provided by the Tendering firm only at their cost and the Academy will not be liable to pay any amount /compensation.
5. In case of any accident, the NEPA or its officers / staff / trainees will not be liable /held responsible for any loss/damage/injury/death and the tenderer will be solely responsible for any such happening.
6. The make and model of Gypsy should not be older than five years and should be in good condition.
7. The validity of offer would be for six month from the date of acceptance.
8. THE TENDERER SHOULD QUOTE "ALL INCLUSIVE RATE PER DAY" i.e. FOR PROVIDING 2 GYPSIES, 2 TRAINED DRIVERS, INCLUSIVE OF POL (PETROL, OIL & LUBRICANT) AND INCIDENTAL CHARGES FOR A DURATION OF 6 HOURS TO TRAIN 72 TRAINEES, BY IMPARTING DRIVING TRAINING AT LEAST 1 KILOMETRE PER TRAINEE, PER DAY BASIS.
9. The payment will be made to the firm on monthly basis as per bills submitted by the firm.

10. **The Director, NEPA reserves the right to accept or reject any or all or part of the tender at any stage without assigning any reason.**
11. The Director, NEPA, will act as arbitrator for any disputes arising out of this and his decision will be final and binding.
12. The firms / corporate body agreeing with above terms and conditions should only apply.
13. The Director NEPA reserves the right to exercise his discretion to terminate the contract without notice, if he find violation of any term and condition as published/agreed.
14. The Tenders whose offer has been accepted should sign an agreement with the Rep. of NEPA agreeing to the terms and conditions.
15. All the tendering firms should enclose a Bank Draft for an amount of Rs. 20,000/- in the form of D.D. as earnest/security deposit payable at S.B.I., Barapani, for which no interest will be payable or deposit money is cash in lieu.
16. The security money of all unsuccessful Bidder will be returned and the security money of successful Bidder will be retained till completion of Driving training which will be returned without interest.
17. The successful bidder who fails to provide the servicing as agreed upon his security money of Rs.20000/- will stand forfeited.
18. The Director NEPA is not bound to accept the lowest rate.
