G.S.R.______---In exercise of the powers conferred by the provisio to article 309 of the Constitution and in supersession of the North Eastern Police Academy, Barapani Group 'A' Post Recruitment Rules 2015, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules for regulating the method of recruitment to the post of **Assistant Director (Official Language)** in the North Eastern Police Academy, Barapani, Shillong, in the Ministry of Home Affairs, namely: -

- 1. Short title and commencement. ---(1) These rules may be called the North Eastern Police Academy, Barapani,, Group 'A' Post Recruitment Rules, 2023.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and pay band and grade pay or pay scale. --- The number of posts, their classification and the pay band and grade pay or pay scale attached thereto shall be as specified in column (2) to (4) of the Scheduled annexed to these rules.
- 3. **Method of recruitment, age-limit, qualification etc.---**The method of recruitment, age-limit, qualification and other matters relating thereto shall be as specified in columns (5) to (13) of the Schedule.
- 4. Disqualification. --- No person,
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living. has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other grounds for so doing exempt any person from the operation from this rule.

- 5. **Power to relax.** ---Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving. Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
