NOTIFICATION

New Delhi, the 1st October, 2013

G.S.R. 675(E).—In exercise of the powers conferred by proviso to article 309 of the Constitution and in supersession of the North Eastern Police Academy, Barapani, Group 'C' posts Recruitment rules 1986, and Ministry of Home Affairs, North Eastern Police Academy, Barapani Group-'C' post Recruitment rules, 1995, in so far as it relate to the post of Nursing Orderly, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Staff Nurse, Pharmacist and Nursing Orderly in the Ministry of Home Affairs, North Eastern Police Academy, Barapani, Shillong, namely:-

1. **Short title and commencement.**—(1) These rules may be called the North Eastern Police Academy, Barapani, Group 'B' and Group 'C' posts Recruitment Rules, 2013.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. **Number of posts, classification and Pay Band and Grade Pay or Pay Scale.**—The number of posts, their classification and the pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these Rules.

3. **Method of recruitment, age limit, qualifications, etc.**—The method of recruitment, age-limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the aforesaid Schedule.

4. **Disqualification.**—No person,

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax.**—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. **Saving.**—Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-serviceman and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note 1. - Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years. The Maximum age limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.

Note 2.- For the purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006, the date from which the revised pay structure based on the 6th Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
