 - (ii) HC(GD),(Band) &(MT) as per VI CPC and VII CPC- PB-1, 5200-20200- Rs. 1900(GP) (Level-02).
 - (iii) ASI(Wireless) as per VI CPC and VII CPC- PB-1, 5200-20200- Rs. 2400(GP) (Level-04).
 - (iv) SI (GD),(Band),(MT),(RM) as per VI CPC and VII CPC- PB-1, 5200-20200- Rs. 2800(GP) (Level-05).
 - (v) Inspector(Line),(Riding),(Wireless),(Trg.) &(TOT) as per VI CPC and VII CPC- PB-2, 9300-34800- Rs. 4200(GP) (Level-06).
3. So far the Para 3 is concerned, no such correspondence is available with us and our Police Personnel pay scale/salary is lesser than the CPMFs.
