With reference to your letter No.RBPUO/RTI/PIO/2005 dated 03/02/2017, the following information are furnished as asked for –

1. The procedure for nominating the candidate for Union Home Minister Medal is prescribed by the BPR&D, which is available on the BPR&D website and can be seen. However a copy of same can be given after receiving the required fee. The above document consist of 20 pages.
2. Hindi language is included in the Basic Course syllabus of Sub-Insp/DySP. The BPR&D has not prescribed any syllabus for Police training to any of the Academies. However a uniform syllabus is under consideration in BPR&D and depending the circumstance prevailing in the region the Academies are allowed to modify the syllabus accordingly.
