The Pay Scale of Deputy Superintendent of Police, NEPA in the year 1984 was Rs. 650 – 30 – 740 – 35 – 810 – EB – 35 – 880 – 40 – 1000 – EB – 40 – 1200/- PM and after re-designation of the post of Deputy Superintendent of Police to Deputy Assistant Director, NEPA after 13/03/1985 was Rs. 650 – 30 – 740 – 35 – 810 – EB – 35 – 880 – 40 – 1000 – EB – 40 – 1200/- PM (copy enclosed).
3. The posts of Deputy Superintendent of Police were created during 1978 and 1979 in the Scale of Rs. 650 – 30 – 740 – 35 – 810 – EB – 35 – 880 – 40 – 1000 – EB – 40 – 1200/- PM and it was re-designated as Deputy Assistant Director during March, 1985. Creation Orders of Deputy Superintendent of Police are enclosed.
