**Sub :- Information sought under the Right to Information Act, 2005- Regarding.**

Sir,

Please refer to application under RTI Act, 2005 dated 6/6/2018 submitted by Shri Ram Sharan, Counter Clerk, Departmental Canteen, the information as asked for is as under, *as provided by APID.*

1. As per para 3 of the letter dated 21/5/2018 addressed to Shri Ram Sharan, Clerk, NEPA under RTI Act, 2005, it is seen from the record that Shri K K Sinha, was promoted from Counter Clerk to the post Canteen Manager w.e.f. 01/9/1987 to 31/7/1990. His educational qualification was Pre-University (10+2) and during that period & the Departmental Canteen was Group 'C' Type.
2. Shri K K Sinha was holding the post of Counter Clerk from 5/7/1986 to 31/8/1987 and holding the post of Canteen Manager from 01/9/1987 to 31/7/1990.
3. As per record there is no such Recruitment Rule for promotion from Canteen Clerk to Canteen Manager of that period is available.
4. The Recruitment Rules of Departmental Canteen has not been amended. However, the copies of proposed amendment in RR has already been given to you through your previous RTI application.
5. From the date of inception, the Departmental Canteen was type 'C' upto 21/8/2007 and type 'D' from 22/8/2007 to 19/9/2011, again type 'C' from 20/9/2011 till date.
6. As and when the departmental canteen was type 'C' initially the staff strength was 10 and when it was downgraded as type 'D' the staff strength was 8.
7. There is no pay fixation during January 2000. However, fixation done vide orders (i) No. NEPA/ACP/1/99/Vol-II-1443-48 dated 18/5/2012 (ii) No. NEPA/Estt/Audit-15/2015/11901-03 dated 14/10/2015 and (iii) pay fixation (IPS) w.e.f. 1.1.2016 are attached herewith.



In case, you are not satisfied with the information provided, you may appeal to Appellate Authority within 30 days from the date of receipt of this letter.



**ORDER**

During inspection of Service records in r/o Shri Ram Saran, Counter Clerk, NEPA by the Internal Audit Wing, GOI, MHA, observed that the incumbent was appointed as Counter Clerk w.e.f. 01.06.1988 in the pay scale of Rs. 825-1200(Revised Rs. 3050-4590). Subsequently, he was granted 1<sup>st</sup> financial upgradation under ACP Scheme w.e.f. 01.06.2000 in the pay scale of Rs. 3200-85-4900. Further he has been granted w.e.f. 22.12.2004 upgraded pay scale of Rs. 4000-100-6000 vide O.M. No. 13/10/2001-Dir (C) dated 22.12.2004 & O.M. No. 3/4/2005-Dir (C) dated 10.04.2006 and pay was fixed Rs. 4200/- with DNI on 01.12.2005. As on 01.01.2006 he was drawing pay of Rs. 4300 in the pre-revised pay scale. 2<sup>nd</sup> MACP has been granted w.e.f. 1.9.2008 in place of 1.6.2010 as per Audit report.
