New Delhi, the 16th December, 1988

G.S.R. 995.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Electrician and Carpenter (Group 'C' posts) in the North Eastern Police Academy, Barapani, namely:—

1. Short title and commencement.—(1) These rules may be called the North Eastern Police Academy, Barapani, (Group 'C') Recruitment Rules, 1988.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number, classification and scale of pay.—The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications etc.—The method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedule aforesaid.

4. Disqualification.—No person,

(a) who has entered into or contracted a marriage with any person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to any of the said post :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

सं. का. वि. 996—राजपति: संविधान के अनुच्छेद 309 के परमबुद्ध द्वारा प्रदत्त शक्तिओं का प्रयोग करते हुए पूर्वोक्त परिषद, जिला में प्रशासनिक अधिकारी (समूह "ख") के पद पर भर्ती की पद्धति का विनियमन करने के लिए निम्नलिखित नियम बनाते हैं: अर्थात्:—

- संक्षिप्त नाम और प्रारम्भ: (1) इन नियमों का संक्षिप्त नाम पूर्वोक्त परिषद जिला में, (समूह "ख") भर्ती नियम, 1988 है।
(2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
- पद संख्या, वर्गीकरण और वेतनमान:— उक्त पद की संख्या उसका वर्गीकरण और उसका वेतनमान वह होगा जो इन नियमों में उल्लेख अनुसूची के स्तम्भ 2 से स्तम्भ 4 में विनिर्दिष्ट है।
- भर्ती की पद्धति, आयु सीमा, अर्हताएं आदि:— उक्त पद पर भर्ती की पद्धति, आयु सीमा, अर्हताएं और उक्त संबंधित अन्य बातें वे होंगी जो पूर्वोक्त अनुसूची के स्तम्भ 5 से स्तम्भ 14 में विनिर्दिष्ट है।

4. निरर्हता, वह व्यक्ति,--

(क) जिसने ऐसे व्यक्ति से जिसका पति या जिसकी पत्नी जीवित है, विवाह किया है, या

(ख) जिसने अपने पति या अपनी पत्नी के जीवित रहते हुए किसी व्यक्ति से विवाह किया है,

उक्त पद पर नियुक्ति का पात्र नहीं होगा।

परन्तु यदि केन्द्रीय सरकार का यह समाधान हो जाता है कि ऐसा विवाह ऐसे व्यक्ति और विवाह के अन्य पक्षधारों को खासू स्वीय विधि के अधीन अनुमति है और ऐसा करने के लिए अन्य आधार हैं तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकेगी।

5. शिथिल करने की शक्ति:— यहाँ केन्द्रीय सरकार की यह शक्ति है कि ऐसा करना आवश्यक या समीचीन है, वहाँ वह, उसके लिए जो कारण हैं उन हैं लेखबद्ध करके तथा संघ लोक सेवा आयोग से परामर्श करके, इन नियमों के किसी उपबंध को किसी दर्जा या प्रवर्ग के व्यक्तियों को बावत, आदेश द्वारा शिथिल कर सकेगी।

6. व्याप्ति:— इन नियमों की कोई बात, ऐसे धारधारों, आवेदनियों में छूट और अन्य रियायतों पर प्रभाव नहीं डालेगी, जिसका केन्द्रीय सरकार द्वारा इस संघ में समय-समय पर निकाले गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों भूतपूर्व सैनिकों और अन्य विशेष वर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।

NOTIFICATION

New Delhi, the 8th November, 2012

S.R. 824(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and supersession of the North Eastern Police Academy, Barapani, Group 'C' posts Recruitment Rules, 1988 in so far as they relate to the post of Multigraph Operator, and the North Eastern Police Academy, Barapani, (Group 'C', Recruitment Rules, 1988, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules for regulating the method of recruitment to the posts of Electrician, Carpenter and Multi-graph Operator in the North Eastern Police Academy, Barapani, Shillong, in the Ministry of Home Affairs, namely:-

1. Short title and commencement. - (1) These rules may be called the North Eastern Police Academy, Barapani, (Electrician, Carpenter and Multigraph Operator) Group 'C' Posts Recruitment Rules, 2012.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Application.- These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.

3. Number of posts, Classification and Pay Band and Grade pay or Pay Scale.- The number of posts, their classification and the pay band and Grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the said Schedule.

4. Method of recruitment, age limit, qualification, etc.- The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in columns (5) to (13) of the aforesaid Schedule.

5. Disqualification.- No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage, and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax.- Where the Central Government is of the opinion that it is necessary of expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect of any class or category of persons.
