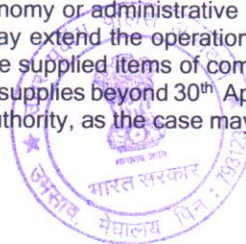
## NOTICE INVITING LOCAL TENDER

Tender No. NEPA/TRG/ISC/LT/2024/

TENDER FOR SUPPLY OF FRESH VEGETABLES, FRESH FRUITS, ONION, POTATOES, MEAT ON HOOF (MOH), CUT MEAT, EGGS (HEN), CHICKEN BROILER (ALIVE), CHICKEN BROILER (DRESSED), FISH FRESH, AS GIVEN IN THE SCHEDULES ATTACHED, FROM LOCAL WHOLESALE DEALERS/ TRADERS WITH FOR THE RESPECTIVE IN-SERVICE COURSE MESSAGES OF THE NORTH EASTERN POLICE ACADEMY, UMSAW, FOR THE PERIOD W.E.F. 01/05/2024 TO 30/04/2025".

1. Sealed quotations superscribed, "Quotations for supply of fresh rations for the in-service messes of NEPA" are hereby invited from local wholesale/retail dealers/ traders/ central or state government agencies on or before 20/04/24, who are engaged in sale of Fresh Vegetables, Fresh Fruits, Onion, Potatoes, Meat on Hoof (MOH), Cut Meat, Eggs (Hen), Chicken Broiler (Alive), Chicken Broiler (Dressed), Fish Fresh, etc. as per **Annexure 'A'** for supply to the respective in-service course Messes of the North Eastern Police Academy, Umsaw, as given in the schedules attached for the period w.e.f. 01/05/ 2024 to 30/04/2025. Rates quoted therein should be valid for a period of 1(one) year.
2. The supply will have to be made at the respective Messes mentioned in the schedules or at any other places falling within the same route (Axis) or within 10 Km radius of the said place, as may be ordered.
3. Billing for the supply of the aforementioned items may be billed on completion of an in-service course(s), which is usually on a weekly basis, but not exceeding 2 (two) weeks, irrespective of the duration of any particular course.
  - (a) All supplies will be on schedule rates per Kg/No. Bidders must quote their rate in terms of per Kg/No. In the case of Eggs, the rate shall be quoted per plate.
  - (b) Any commodity which is not controlled/ price controlled at the time of publication of the tender notice or submission of the tender but becomes controlled/ price controlled subsequently during the currency of the supply, will have to be supplied by the appointed suppliers at wholesale controlled rate plus transportation charges, as long as the control over such commodity remains operative. If the control is lifted then item supplied will be paid for at scheduled supply rates.
  - (c) All supplies will be for net weight of the commodities only. No claim for payment of the cost of container/bag will be entertained.
  - (d) The supply when awarded will remain operative upto 30<sup>th</sup> April 2025, subject to other conditions of the supply. In the interest of state economy or administrative necessity, the Competent Authority, North Eastern Police Academy, as the case may be, may extend the operation of supply beyond 30<sup>th</sup> April 2025, and in that case the supplier will be bound to supply the supplied items of commodities at the same supplied rates and under the same terms and conditions. Extension of supplies beyond 30<sup>th</sup> April 2025, may be made only on mutual agreement between the supplier and the Competent Authority, as the case may be.



(e) Taxes imposed by State Govt. from time to time on supplied items will be deducted from the supplier's bills and deposited to State Govt account under appropriate budget head/revenue head.

(f) Total value (Basket Value) of supply will be considered for deducing the L1 tenderer. Value of individual commodities will not be considered.

(g) Above particulars may change due to administrative or any other reasons and shall be available on [www.nepa.gov.in](http://www.nepa.gov.in). Therefore, bidders/ suppliers are requested to visit the given website frequently for changes in above particulars.

(h) Terms and conditions given in this notice of tender shall form part of the supply. The tender particulars are:
