

CONDITONS OF SALE

1. Public auction for Govt. vehicles namely ML 10 7325 (LMV Maruti Gypsy Soft Top) will be auction on **03/11/2023, at 11.00 hrs**. In case it is holiday then the date of auction will be held in the next working day in NEPA, on '**AS IS WHERE IS BASIS**'.
2. Subject to realization of reserve price where the same has been fixed by a Board of Officers of the North Eastern Police Academy, Umsaw, the vehicles will be sold to the highest bidder.
3. Every bidder shall have to deposit Rs. 10,000 /- (Rupees Ten Thousand) only as Security Deposit, before the Bid, without which no permission for bid will be allowed. The Security Deposit will be refundable to the unsuccessful bidders on finalization of the sale.
4. The buyer has to pay the full amount of the sale value in cash to the Cashier of the North Eastern Police Academy within two days of acceptance of his offered and accepted rate at the auction. If the buyer fails to make full payment of the sale value by the stipulated date, his security deposit will be forfeited and the vehicles shall be resold as and when the Govt. deems best without any notice to the successful bidder.
5. Any sale tax/excise duty, road tax etc. which becomes payable to the government upon the sale of the vehicles shall be paid by the purchaser in addition to the sale value. Any other tax due in respect of the sale, under any law for the time being in force shall be payable by the purchaser in addition to the sale value. The successful bidder will have to obtain clearance from sales tax department after paying full payment of sale tax/excise duty if levied.
6. **CONDITION OF THE VEHICLE:** The vehicles sold as is where is condition. The vehicles will also be sold on the assumption that the bidders have inspected the vehicles and know what they are buying.
7. **RISK:** The vehicles shall remain where it is, at the risk of the buyer from the date of acceptance of his bid by the Director, NEPA, and the Govt. shall not be liable for safe custody or preservation thereof from the date of bid till the date of final removal.
8. **DELIVERY:** The vehicles shall be taken from the site as it is, with all faults and errors in description or otherwise. NO WARRANTY OR GUARANTEE shall be implied. The North Eastern Police Academy, Umsaw, will hand over the vehicle to the buyers on production of cash receipt being the full payment of sale value issued by the Cashier of NORTH EASTERN POLICE ACADEMY.
9. The vehicles sold will be removed by the buyer from the site where it lies, within 2 (two) days from the date of sale. The purchaser will make his own arrangement for transportation.

10. The successful bidder will also be responsible for getting the Registration Certificate of the vehicles transferred in his name at his own cost expeditiously. It will be the sole responsibility of the buyer for getting the necessary paper works done in accordance with the law and as per the provision of the Motor Vehicles Act (from time to time). This office will not be responsible for any lapse on the parts of the buyer in this regard.
11. The successful bidder shall have kept the vehicles transferred in his name at his own cost and responsibility, immediately on taking the delivery and in any case within the time prescribed for this purpose. NEPA, shall not be any manners be consented with or responsible for registration of the vehicles will be have no liability after the delivery of the vehicles to the successful bidder.
