The cadre controlling authorities may ascertain that the particulars sent by the officers are correct as per the service record. While forwarding the nominations for the post of Sub-Inspector (General Duty), it may kindly be ensured that the nominated officers should not be in pay scale higher than the pay scale of the deputation post, i.e., level-5 in the pay matrix.


